



WAIVER AND RELEASE OF LIABILITY

PART A – PARTICIPANT WAIVER – RELEASE FROM LIABILITY

Each of the undersigned further expressly agrees that the foregoing release and waiver agreement is intended to be as broad and inclusive as is permitted by the law of Oklahoma and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representation, statements or inducement apart from the foregoing written agreement have been made.

This waiver release and indemnification agreement specifically embraces each and every activity sanctioned or promoted by said release during the entire duration of the activities and applies to each and every event, or activity herein mentioned and has the same effect as executed after each and every activity or event in which the undersigned participates so that the parties herein intended to be released and indemnified shall be fully and effectively released and indemnified as to each and every activity herein described.
